DRAFT FINAL REPORT OF THE 2023 AFRICA DOMAIN NAME INDUSTRY STUDY

The Registries Stakeholder Group (RySG) acknowledged that the 2023 African DNS Study is a rich and detailed resource on Africa's Digital environment but suggested that the report be more focussed on the DNS Industry in its analysis and recommendations. In addition, the RySG submitted detailed comments and questions on specific item in the report.

DRAFT ICANN FY25 PLANS

The Registries Stakeholder Group (RySG) provided comments on ICANN's FY25 Plans. In line with previous comments, it expressed concerns about the complexity of ICANN's Budget documentation and invited ICANN to simplify its financial reporting. In line with ICANN's guidance about the termination of the additional budget request (ABR) process, the RySG included an additional budget request in its comment. The RySG further provided comments on Operating initiative 9 (new gTLD auction proceeds recommendations) and Operating initiative 11 (ICANN Reserves).

DRAFT NCAP STUDY 2 REPORT AND RESPONSES TO QUESTIONS REGARDING NAME COLLISONS

The Registries Stakeholder Group (RySG) encouraged the Board to take into account ICANN staff's contribution and analysis of privacy issues. As evidenced by the RySG's engagement in community efforts, the RySG has experience and interest in addressing privacy concerns. We appreciate the Board's consideration of the issue and are happy to share our expertise and experience as appropriate. The RySG supports the Board maintaining momentum on these recommendations while looking for constructive and efficient ways to continue to examine the highlighted concerns. As this topic has been identified as on the critical path for the ongoing Subsequent Procedures work, we encourage prompt review by the Board.

PHASE 1 FINAL REPORT OF THE EPDP ON INTERNATIONALIZED DOMAIN NAMES

The Registries Stakeholder Group (RySG) noted that in developing recommendations, the EPDP WG should be mindful of maintaining a balance between creating rules for IDNs that promote security and stability, but are not so onerous that they create an undue burden for Registry Operators to operationalize IDNs and offer them to

customers. The RySG supports the ability to offer IDNs to enable domain name registrants to register and use domain names in the languages and scripts they use, but at the point where IDNs become too difficult to implement, that hampers the ability of Registry Operators to offer that service to those users.

PROPOSED LANGUAGE FOR DRAFT SECTIONS OF THE NEXT ROUND APPLICANT GUIDEBOOK

STRING SIMILARITY REVIEW GUIDELINES

The Registries Stakeholder Group (RySG) appreciates the opportunity to comment on this issue. PROPOSED BYLAWS UPDATES TO LIMIT ACCESS TO ACCOUNTABILITY MECHANISMS

The RySG does not believe the proposed Bylaws amendment is an appropriate method for implementing the CCWG's Recommendation 7, but would instead support a more narrowly scoped amendment, limited to restricting access to the Accountability Mechanisms for decisions made as part of ICANN's Grant Program.

REVIEW OF THE REGISTRY SYSTEM TESTING 2.0 TEST SPECIFICATIONS AND API

The RySG suggested including an OT&E test environment with the API interface in order to fully assess and determine if the code suggested is properly reflecting the recommendations of the SubPro PDP final report and suggested including clarification on how to address the case for TLDs operating under IDN rules / policies that precede the SubPro Final Report.

PHASE 2 INITIAL REPORT OF THE EPDP ON INTERNATIONALIZED DOMAIN NAMES

The RySG provided feedback on the twenty (20) preliminary recommendations, which focus on Phase 2 questions included in the EPDP Team's charter on the following topics: "Same entity" at the second-level and IDN Table harmonization; Adjustments in registry agreement, registry service, registry transition process, and other processes/procedures related to the domain name lifecycle; Adjustments in registration dispute-resolution procedures and trademark protection mechanisms; and Process to update the IDN Implementation Guidelines.
